No. LJD. 91/82/3, the 27th. March, 1982. The following Act of the Misoram Legislative Assembly, which received the assent of the Lt. Governor (Administrator) of Mizoram, is hereby published for general information.

Mizoram Act No. 1 of 1982 The Mizoram Appropriation Act, 1982

(Received the assent of the Lt. Governor (Administrator) of Mizoram on the 26th. March, 1982)

AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the Union territory of Mizoram for the services of the financial year 1981—'82.

BE it enacted by the Legislative Assembly of Mizoram in the Thirty-third Year of the Republic of India as follows:—

- 1. This Act may be called the Mizoram Appropriation Act, 1982.
- 2. From and out of the Consolidated Fund of the Union Territory of Mizoram, there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of thirteen crores forty eight lakes and eighty one thousand rupees towards defraying the several charges which will come in course of payment during the financial year 1981—82 in respect of the services specified in column 2 of the Schedule.
- 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
