#### THE MIZORAM ANIMAL (CONTROL AND TAXATION) RULES, 1982

In exercise of the powers conferred by section 31 of the Mizoram Animal (Control and Taxation) Act, 1980 (Act No. 4 of 1980), the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to make the following rules, namely :—

#### CHAP TER I Prelim inary

1. Short title, extent and commencement .-- (1) These rules may be called the Mizoram Animal (Control and Taxation) Rules, 1982.

(2) They shall extend to the whole of the Union Territory of Mizoram except the areas within the jurisdiction of Chakma, Lakher and Pawi District Councils in Chhimtuipui District.

(3) They shall come into force on such date as the Administrator may, by notification in the Mizoram Gazette, appoint and different dates may be appointed for different provisions of these rules or of different areas.

2. Definitions — In these rules, unless the context otherwise requires, —

(a) "Act" means the Mizoram Animal (Control and Taxation) Act, 1980 (Act No. 4 of 19

(b) "Form" means a Form in Schedule I;

(c) "Schedule" means a Schedule to these rules;

(d) "section" means a section of the Act.

#### CHAPTER II Control of animals

3. Disposal of animal dung, excreta, etc. — The owner of an animal shall not allow animal dung, excreta, urine, feeding left-over, wet and damp soils caused by animal on the ground, to remain in such a manner as to cause public nuisance in whatever form.

#### CHAPTER III

Seizure of animals in areas other than towns.

4. Register for purposes of section .— The register to be kept by the Village Council for animals seized and brought under sub-section (1) of section 7 shall be in Form 'A'.

5. Feeding charges for seized animals in areas other than towns.— The daily feeding charges for every animal for the purposes of sub-section (2) of section 8 shall be as follows :—

6. Fines for animals in areas other than towns.

(2) Receipt of payment of feeding charges and fines shall be given by the Village Council to the owner of the animal or his agent in Form 'B'.

1. Procedure for sale of animal by public auction in areas other than towns. — If an animal seized is to be sold by public auction under sub-section (1) or sub-section (2) of section 10, the public auction shall be conducted as follows:

(a) The Village Council shall cause to be announced through a village crier the date, time and place for the auction of the animal;

(b) The successful bidder will have to pay the full amount of his bid on the spot.

#### CHAPTER IV

Seizure of animals in towns

Maintenance of animal register in animal-pound. The register to be kept by pound-keeper under sub-section (1) of section 13 shall be in Form 'C'.

9. Returns for purposes of section 13. — The pound-kesper shall furnish to the Town Committee quarterly seturns of impounded animals in Form 'D'. The return shall be submitted within 10 days after the end of each quarter.

10. Declaration of ownership in town areas. — The deplaration to be made by the owner or his agent before release of impounded animal under sub-section (1) of section 16 shall be in Form 'E'.

11. Security deposit in town areas.— (1) For the purpose of section 16, the security deposit to be made by the owner of his agent before release of animal shall be at the rate specified below —

(2) The pound-keeper shall issue a receipt for the security deposit made un er sub-rule (1) in Form 'F'.

(3) For the purpose of sub-section (2) of section 16 the question whether the whole of part of the security is to be forfeited to the Town Committee shall be decided by the pound-keeper having regard to the circumstances of each case,

12. Sale of animal by public auction in town areas — (1) III under sub-section (1) or sub-section (2) of section 17 an impounded animal is to be sold by anticient it shall be compared as follows :--

(a) The Town Committee shall cause to be notified their intention of the sale fixing the date, time and place in such a manner as to give wide notice to the public:

(b) The successful bidder will have to pay the full arousent of his bid one the spot.

(2) If an impounded animal is not sold by public auction under sub-rule (1), and is to be disposed of under the proviso to sub-section (2) of section 17, it shall be disposed of by the Town Committee by killing the animal and selling its meat in market.

12. Pound-fees and expenses in animal-pound.

(1) The daily pound-fee chargeable for every animal under sub-section, (1) of section 18 shall be as follows :---

#### CHAPTER V

Procedure for collection of animal taxes

14. Village Council to register animals in areas other than towns .--

(1) For the purposes of sub-sections (1) and (2) of section 21, every owner of animals shall report, once in a financial year within the month of April the number of animals (adult and young) owned by him, to the Village Council concerned who shall enter the particulars in the register maintained for the purpose in Form 'G'.

(2) The Village Council shall keep account of registration fee in Form 'H'.

(3) On payment of the registration fee under sub-section (1) of section 21, the Village Council shall issue a receipt for it in Form 'I'.

15. Town Committee to register animals in towns.— (1) For the purposes of sub-sections (1) and (2) of section 21, every owner of animals shall report, once in a financial year within the month of April the number of animals (adult and young) owned hy him, to the Town Committee concerned who shall enter the particulars in the register maintained for the purpose in Form 'J'.

(2) The Town Committee shall keep account of registration fee in Form 'K'.

(3) On payment of registration fee under sub-section (1) of section 21, the Town Committee or the officer authorised by it shall issue a receipt for it in Form 'L'.

16. Collection of animal taxes by Village Council.— (1) Every owner of animals in areas other than towns shall pay animal taxes to the Village Council concerned in respect of his animals at the rates setforth in Schedule II in one instalment in a financial year during the month of April or in two half yearly instalments in the month of April and October respectively.

(2) The Village Council shall keep account of animal taxes in Form 'M'.

(3) On payment of the animal taxes under sub-rule (1), the Village Council shall issue a receipt for it in Form 'N'.

17. Collection of animal taxes by Town Committee .-- (1) Every owner of animals in towns shall pay to the Town Committee animal taxes at the rates settorth in Schedule II in one instalment in a financial year during the month of April or in two half yearly instalments in the months of April and October respectively.

(2) The Town Committee shall keep account of animal taxes in Form 'O'.

(3) On payment of animal taxes under sub-rule (1), the Town Committee shall issue a receipt for it in Form 'P'.

18. Procedure for creditting animal taxes collected.— For the purposes of sub-section (3) of section 20, fifty percent of animal taxes collected by Town Committee and by the Village Council shall be creditted to the Consolidated Fund of the Union territory of Mizoram under the head and the balance of fifty percent shall be creditted to the respective local fund.

19. Appeal.— Any person aggrieved by an order of the Town Committee, the Village Council or other authority or officer under section 22 may appeal to the District Magistrate concerned within forty five days from the date of receipt of the order.

#### CHAPTER VI

#### Miscell aneous

20. Application for licence — (1) If a person is desirous of keeping animals in a prohibited area under section 29, he may apply for a licence in Form 'Q'. (2) The licence for the purpose shall be in Form 'R'. SCHEDULE I


