NOTIFICATIONS

No.A. 12018/8(ii)81-APT(B), the 25th May, 1982. In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/16/16-HM (ii) date the 21st January, 1972 and all other powers enabling him in his behalf the Nd ministrator of Mizoram is cleased to make the following rules relating to the Caster A tendant, Bindery Assistant, Helper & Michine Attendant in the Government Press under Printing & Stationery Department of Government of Micoram, namely:—

1. Short title and Commencement

1) Trese Rules may be called the Mizoram Printing & Stationery Department (Group 'D' post) Recruitm nt Rules, 1982.

2. Application

2) They sha'l come into force on the date of their publication in the O ficial Gazetts.

3. Number of posts classification and scale of pay

The Rules shall apply to the post specified in Column 1. of the Schedule hereto annexed.

4 Method of rectt. age limit and other qualification

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the scheduled aroresaid.

The age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 5 to 13 of the said Scheduled.

Provided that the upper age 'imit prescribed for direct recit, may be relaxed in the case of candidates belonging to the scheduled Castes, Scheduled Tribes and other special categories of persons in accord nee with the orders issued by the Contral Govt. or Govt. of Mizoram from time to time.

5. Disqualification

No person.

a) Who has entered into or contracted a marriage with a person having a spouse living,

b) Who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permission under the personal law applicable to such person and the other grounds for so doing exempt any person from the operation of this rules.

6. Training and Departmental Examination

Every Govt. servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.

7. Power to relax

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8. Reservation other concession

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

9. Repeal and Saving

All Rules pertaining to these posts, framed by the Governor of Assam or by the Govt of Assam and were in force in the ertswhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT(ii) dt.21.1.1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding

provisions of these rules.
