NOTIFICATIONS

No. VET. 12/79/197, the 23th Sept., 1981. In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the posts of i) Sub-Divisional A.H & Vety. Officer, ii) V.A.S./Extension Officer/Farm Manager, iii) Assistant Disease Investigation Officer, iv) Assistant Dairy Development Officer, v) Assistant Information & Statistical Officer, vi) Project Officer, and vii) Assistant Engineer, under A.H. & Vety. Department of Mizoram, namely :—

1. Short title and commencement : 1) These Rules may be called the Mizoram, Animal Husbandry & Vety. Deptt. (Group 'B' Posts) Recruitment Rules, 1981.
2) They shall come into force on the date of their publication in the Official Gazette.
2. Application : These Rules shall apply to the post specified in column 1 of the Schedule hereto annexed.
3. Number of posts classification and scale of pay : 3) The number of the said posts, their classification and the scales of pay attached thereto shall be as specified in columns 2 to 4 of the Scheduled aforesaid.
4. Method of recruitment age limit and other qualification : The age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 5 to 13 of the said Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualifi- : No person;
 cation
- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 6 Training and : Every Government Servant shall undergo such training
 Departmental or pass such departmental examination as may be prescribed

- 7 Power to : Where the Administrator is of the opinion that it is neces-
