No. LJD. 5/79/27, the 13th November, 1981. The Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to make the following amendments in the Rules relating to duties, fees, etc. of the Standing Counsel, Government of Mizoram, published in Notification No. LJD, 93/74/79, dat d the 1st October, 1975 in the Mizoram Gazette Extra Ordinary, dated the 1st October, 1975, namely:--

Amendments

In the said Rules,— (1) in clause (c) of rule 1, for the figures "500.00," the figures "750" substituted;

(2) in rule 6,—

(a) for sub-rule (1), the following sub-rule shall be substituted, namely:—

"(1) Subject to the provisions of sub-rule (2), the Standing Counsel shall be allowed a fee of Rs.

150 for any day on which he appears b fore the High Court on behalf of the Government of Mizoram in any case or appeal":

(b) in sub-rule (2), for the words "more than one case in a day, he will be entitled to get the highest daily fee fixed for any of those cases," the words, brackets and figure, "more than one case or appeal in a day, he will be entitled to get only one daily fee as fixed under sub-rule (1)" shall be substituted: tituted

(3) in rule 7, for the figures "200" the figures "300" shall be substituted.

The above amendments shall be deemed to have come into force with effect from the 16th June, 1980.
