Now, therefore, in pursuance of the provisions contained in section 15 of the Representation of the People Act, 1951 (43 of 1951), the Administrator of Mizoram is hereby pleased, as recommended by the Election Commission, to call upon all assembly constituencies in the Union Territory to elect members in accordance with the provisions of the said Act and of the Rules and Orders made thereunder.

## NOTIFICATION

No. 464/MIZ-LA/84 (I) :— Whereas the Administrator of Mizoram has, by notification under section 15 of the Representation of the people Act, 1951 (43 of 1951), published in the Official Gazette of the Union Territory on the 22nd March, 1984, called upon all the assembly constituencies in the Union Territory of Mizoram to elect members for the purpose of constituting new Legislative Assembly for that Union Territory :

Now, therefore, in pursuance of the provisions of section 30 of the said Act, the Election Commission hereby appoints with respect to the said election :—

- (a) 29th March, 1984 (Thursday) as the last date for making nominations;
- (b) 30th March, 1984 (Friday) as the date for scrutiny of nominations;
- (c) 2nd April, 1984 (Monday) as the last date for the withdrawal of candidatures;
- (d) 25th April, 1984 (Wednesday) as the date on which a poll shall, if necessary, be taken; and
- (e) 2nd May, 1984 (Wednesday) as the date before which the election shall be completed.
