NOTIFICATION

No. 318/MIZ/84 (1).— Whereas the President has, by notification published in the Gazette of India on the 18th June, 1984, called upon the elected members of the Legislative Assembly of the Union Territory of Mizoram to elect to the Council of States one member from that Union Territory;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 39 of the Representation of the People Act, 1951, the Election Commission hereby appoints with respect to the said election.—

- (a) 25th June, 1984 (Monday), as the last date for making nominations ;
- (b) 26th June, 1984 (Tuesday), as the date for the scrutiny of nominations ;
- (c) 28th June, 1984 (Thursday), as the last date for the withdrawal of candidatures ;
- (d) 5th July, 1984 (Thursday), as the date on which a poll shall, if necessary be taken ; and
- (e) 9th July, 1984 (Monday), as the date before which the election shall be completed.
