## NOTIFICATIONS

No. DCA/E—238/85/13, the 25th January, 1985. In pursuance of Rule 141(1) of the Mizoram Autonomous District Councils (Constitution and Conduct of the District Councils) Rule, 1974, it is hereby notified for information of all concerned that the date and hours of Poll for Election to Lakher District Council, 1985 is fixed according to the Schedule given below:—

Date of Poll (for all the Constituencies) — 14. 2. 1985

Hours of Poll (for all the Constituencies) — 7:30 A. M. to 4:00 P. M.

No. DCA/E—238/85/12, the 25th January, 1985. Whereas by Notification No. DCA/E—238/85/3 dated 19. 1. 1985 issued under sub-section (2) of rule 125 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules 1974, every constituency in the Lakher Autonomous District Council was called upon to elect a member for constituting the new District Council;

Now, therefore, in exercise of the powers conferred by rules 134, 136 and 141 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of the Union territory of Mizoram is pleased to appoint with respect of the said election:—

- (a) The last date and time upto which the nomination papers may be delivered to the Returning Officer to such other person as may be authorised in this behalf by the Returning Officer — 1st February, 1985 from 11 A.M. to 3:00 P. M.
- (b) The Scrutiny of the Nomination papers will commence after 3:00 P. M. on 1st February, 1985 at such place the Returning Officer may appoint and if it cannot be completed on that day it shall be completed on the next working day.
- (c) The withdrawals of the nomination, if any, may be delivered to the Returning Officer at any time before the Returning Officer has completed the preparation of the list of valid nominations under sub-rule (4) of Rule 136.

- (d) The time and date on which the polling, if necessary, shall be taken in all constituencies — from 7:30 A. M. to 4:00 P. M. on 14. 2. 1985.

This supersedes the earlier notification issued vide No. DCA/E - 238/85/5 dated 19th Jan., 1985.

- NOTE:— (1) The order in this precedence is meant for State and ceremonial occasions alone and has no application in the day-to-day business of the Government.
- (2) Persons in the Table of precedence will take rank in order of the number of article. Those included in the same rank will take precedence inter-se according to the dates on which they enter into that entry except the following:—
- (a) Speaker of the Legislative Assembly will take precedence over Ministers.
  - (b) Leader of Opposition in the State Legislature and Govt. Whip in the State Legislature will take precedence over others in the same article.
  - (c) GOC, 57 Mountain Division located in Mizoram will take precedence above the I.G.P., Development Commissioner and Chief Conservator of Forests as per Government of India's instruction No. 12/15/73—Pub—II dated 14/3/75.
