NOTIFICATION

No. A. 12018/85/80-APT (B), the 20th May 1985. In exercise of the powers conferred by the proviso to Article 309 of the constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated 21.1.1972 and of all other powers enabling him on this behalf, the Administrator of Mizoram is pleased to make the following rules to amend the Mizoram Stenographers Grade-II and Grade III (Group 'C' posts) Recruitment Rules, 1980 issued under Notification No. ABR. 56/77/82-87 dated 28 7.1980, namely:-

- 1. Short title and i) commencement. These rules may be called the Mizoram Stenographer Grade II & Grade III (Group 'C' posts) Recruitment (First Amendment) Rules, 1985.
 - ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the schedule of the Mizoram Stenographer Grade-II and Grade-III (Group 'C' post) Recruitment Rules, 1980 (hereinafter referred to as the said Rules) the existing provisions in (ii) (3) (a) under Col. 7 in respect of Stenographer Grade II shall be deleted and (ii) under the same column for the same post shall be substituted by the following:-

- (ii) Should pass Competitive Examination conducted by the Department of Personnel & Administrative Reform on the following subjects:-
 - (1) English.
 - (2) General Knowledge.
 - (3) Speed test in shorthand at 120 words per minute for 3 minutes.

3. In the schedule of said Rules, the existing provisions under column 11 in respect of Stenographer Grade II shall be substituted by the following provisions:-

"PROMOTION : from working Stenographer Grade III who passed speed test in shorthand at 120 works per minutes and having not less than 2 years service in the grade".

4. In the schedule of the said Rules, the existing provisions in (ii) (3) (b) under Col. 7 in respect of Stenographer Grade 111 shall be deleted and (ii) under the same column for the same post shall be substituted by the following :--

- (ii) Should pass Competitive Examination conducted by the Department of Personnel & Administrative Reform on the following subjects :---
- (1) English.
- (2) General Knowledge.
- (3) Speed test in shorthand at 80 words per minute for 5 minutes.

5. In the schedule of the said Rules, existing entries under Col. 12 in respect of Stenographer Grade II & III, one of the members at (3) shall be deleted and entries ander the same column shall be substituted by the following :--

" The Departmental Promotion Committee should consist of-

- (1) Secretary, Department of Personnel and Administrative ReformsChairman.
- (2) Secretary, General Administration Department. Member.
