#### NOTIFICATION

No. A. 12018/50/80-APT (B), the 7th August, 1985. In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the post of Research Assistant and Publicity Assistant in Forest Department of Government of Mizoram, namely:---

- 1. Short title 1. These Rules may be called the Mizoram Forest Department and Commencement: (Group 'C' posts) Recruitment Rules, 1985.
  - 2. They shall come into Force on the date of their publication in the Official Gazette.
- 2. Application: The Rules shall apply to the posts specified in Col. 1 of the Schedule hereto annexed.

3. Number of The number of the said posts, their classification and the scale posts, classifiof pay attached thereto shall be as specified in columns 2 to 4 to the Schedule aforesaid. scale of pay:

4. Method of The age limit qualifications and other matters relating to the rectt., age limit and other schedule. gualification:

> Provided that the Upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

- 5. Disqualification
- No person.
  a) Who has entered into or contracted a marriage with a person having a sponse living.

b) Who having a spouse living has entered interor contracted matriage with any person shall be eligible for appointment to the said post.

Provided that the Administrator may; if satisfied that such marriage is permission under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rules.
