NOTIFICATION

No. A. 12018/8 (ii)/81-APT(B), the 28th January, 1986. In exercise of the powers conferred by proviso to Article 309 of the constitution read with the Govt. of India, Ministry of Home Affair's Notification No. 14/21/71-HMT(ii) dt. 21. 1. 72 and of all other powers enabling him in this behalf, the Administrator of Mizoram hereby makes the following rules further to amend the Mizoram Govt. Press (Group 'C' posts) Recruitment Rules, 1979 published in the Official Gazette dated 26.3.1980 under Notification No. IPR/E-26/80/17 dt. 26.3.1980 namely :-

- 1. (1) These rules may be called the Printing & Stationery Department (Group 'C' posts) Recruitment (First Amendment) Rules, 1985.
 - (2) They shall come into force from the date of their publication in the Official Gazette.

2. In the Annexure I of the Mizoram Govt. Press (Group 'C' posts) Recruitment Rules, 1979 (Herein after referred to as the said rules) for existing entries under -Col. 1 for the post of Printer, Gr. III the following proviso shall be substituted – "Machineman Gr. III".

3. In the Annexure I of the said rules, for the existing entries under Col. 6 for the post of Printer, Gr. III the following proviso shall be substituted :--

"Between 18 yrs. and 25yrs. (relaxable for Govt. servants upto 5 yrs. in accordance with instructions or orders issued by Central Govt.)". See foot note.

FOOT NOTE : The crucial date for determining age limit mentioned in Col. 6 of the Recruitment Rules will, in each case, be the closing date for receipt of applications from candidates in India (other than Andaman & Nicobar Islands & Lakshadweep).

In respect of posts, appointment to which are made through the Employment Exchanges, the crucial date for determining age limit will, in each case, be the last date upto which the Employment Exchanges are asked to submit the names. 4. In the Annexure I of the said rule, for the existing entries under Col. 10 for the post of Printer Gr. III the following proviso shall be substituted :-

"100% promotion failing which by direct recruitment".

5. In the Annexure I of the said rule for existing entries under Col. 11 for the post of Printer Gr. III the following proviso shall be substituted :

"Promotion : from male Machine Attendant and Proof Puller and Distributor having experience of nct less than 3 yrs. in the grade".

- 1. (1) These rules may be called the Mizoram Printing and Stationery Department (Group 'C') Recruitment (First Amendment) Rules, 1985.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution read with the Govt. of India, Ministry of Home Affair's Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the post of Watch and Ward Staff in the Printing & Stationery Department of Government of Mizoram, namely :--

- Short title 1. These Rules may be called the Mizoram Printing & Stationery and Commencement:
 Croup 'D' posts) Deptt. Recruitment Rules, 1985.
 - 2. They shall come into force on the date of their publication in the Official Gazette.
- 2. Application: The Rules shall apply to the posts specified in Col. 1 of the Schedule hereto annexed.
- 3. Number of posts, classification and scale of pay: The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 to the Schedule aforesaid.
- 4. Method of The age limit, qualifications and other matters relating to the rectt., age limit and other schedule. qualification:

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central, Govt, or Govt, of Mizoram from time to time. Ex-6/86

5. Disgualification. : No person.

- a) Who has entered into or contracted a marriage with a person having a spouse living;
- b) Who having a spouse living has entered into or contracted marriage with any person shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permission under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rules.

- 6. Training and Every Govt. servant shall undergo such training or pass such Departmental Departmental Examination as may be prescribed from time to time.
- 7. Power to relax: Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
- Reserva- N tion, other concessions : th

Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt.of Mizoram from time to time in this regard.

9. Repeal and Saving : All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21.1.1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
