THE MIZORAM SALARIES, ALLOWANCES AND PENSION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 1985.

AN

ACT

further to amend the Mizoram Salaries, Allowances and Pension of Members of the Legislative Assembly Act, 1973

Be it enacted by the Legislative Assembly of Mizoram in the Thirty-sixth year of the Republic of India as follows :-

1. This Act may be called the Mizoram Salaries, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 1985

2. In section 8B of the Mizoram Salaries, Allowances and Pension of Members of the Legislative Assembly Act, 1973 :--

(a) for sub-section (1), the following sub-section shall be substituted, namely :- "(1) With effect from the 1st day of January, 1982, there shall be paid a pension of two hundred rupees per mensem to every person who has served for a period of five years, whether continuous or not, -

- (i) as a member of the Legislative Assembly or the State or Assam representing any territory which after the 21st day of January. 1972, forms part of the Union territory of Mizoram; or
- (ii) as a member of the Assembly :

Provided that any person who has served as aforesaid for a period which falls short of five years by not more than sixty days, shall also be paid a pension of two hundred rupees per mensem.

Provided further that where any person has served as aforesaid for a period exceeding five years, there shall be paid to him an additional pension of fifty rupees per mensem for every year in excess of five years, so, however, that in no case the pension payable to such person shall exceed four hundred rupees per mensem.

(b) for sub-section (4), the following sub-section shall be substituted, namely :-

> "(4) In computing the number of years for the purpose of sub-section (1), the period during which —

(a) a person referred to in clause (i) of sub-section (1) has served as a Minister or a Deputy Minister as referred to in the Assam Ministers' and Deputy Ministers' Salaries and Allowances Act, 1958, or as a Speaker as referred to in the Assam Speker's Salaries and Allowances Act, 1958 or as a Deputy Speker as referred to in the Assam Deputy Speaker's Salaries and Allowances Act, 1958, or as a Parliamentary Secretary as referred to in the Assam Parliamentary Secretaries (Allowances and Privileges) Rules, 1960 or both : and

(b) a person referred to in clause (ii) of sub-section (1) has served as Minister as defined in the Mizoram Salaries and Allowances of Minister Act, 1973, or as a Speaker or a Deputy Speaker as defined in the Mizoram Salaries and Allowances of the Speaker and Deputy Speaker Act, 1973, or both.
