NOTIFICATION

No. FOR.335/85/130 : the 28th April 1986. The Lt. Governor (Administrator) of Mizoram is pleased to re-constitute Aizawl Forest Division under Forest Department as per boundary description stated below with effect from the date of issue of this Notification, with its Headquarters at Aizawl.

BOUNDARY DESCRIPTION OF AIZAWL FOREST DIVISION

- NORTH : Boundary started from the junction where Khuai Lui stream meet the river Tlawng, then it runs upstream and crosses Sairang—Kawnpui road and follows the stream upto its a stream which has its source from east of Serkhan Village upto river Tuirial. Then it follows upstream the river Tuirial upto its confluence with the River Tuirini. Then it follows up the River Tuirini upto the junction where Tuikhuau Lui stream meet River Tuirini. Then it follows upstream of Tuikhuau lui upto its source up-ward and then it follows eastward straight upto River Tuivawl.
 - EAST : Where the boundary meet the River Tuivawl, it runs upstream along the river bank of River Tuivawl and it crosses the Seling Champhai road between Khawthlir and Kawlkulh Village, then it follows upstream upto the source of River Tuivawl. Then it runs eastward meeting the foot path between Rullam and Vancheng Village, and curves down ward and meet the source of River Tuichang. (This form parts of Western boundary of Champhai Division). Then it follows the river bank of river Tuichang downward upto the point near Bungtlang Village. (This forms parts of Northwest boundary of N. Vanlaiphai Division).
 - SOUTH : From the river bank of River Tuichang near Bungtlang Village it runs upward, crossing Serchhip to Lunglei Road between Chawngtlang and Bungtlang Village, and then it follow the inter-District Boundary of Aizawl and Lunglei District, and then it runs westernly direction till it meet River Tlawng.

WEST : From the point where the boundary meet River Tlawng it follows downward the river bank towards the Northern direction upto the starting point.

2. This Notification supersedes the boundary description relating to Aizawl East Forest Division, which was subsequently renamed as Aizawl Forest Division vide Notification No. FOR.256/80-84/192 dt.30 10.1984 issued earlier vide this Department Notification No. FOR. 37/74-80/91 dt. 30.3.1981.
