NOTIFICATION

No. A. 12018/78/80-APT(B), the 30th May, 1986. In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st. January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the post of Record Keeper under the Deptt. of Land Revenue & Settlement, Govt. of Mizoram, Namely :-

- mencement:
- 1. Short title 1. These Rules may be called the Mizoram Land Revenue and Settleand Com- ment, Deptt. (Group 'C' post) Recruitment Rules, 1986.
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 2. Application: The Rules shall apply to the posts specified in Col. 1 of the Annexure I hereto annexed.
- 3. Numbers of posts. classification and scale of pay:
- The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of rectt. age limit and other qualification:

The age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt, or Govt, of Mizoram from time to time.

Disqualification:

No person.

a) Who has entered into or contracted a marriage with a person having a spouse living.

b) Who having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing, exempt any person from the operation of this rules.

Training and Departmental Examination:
