NOTIFICATION

No. A-11016/84-AGR, the 23rd July, 1986. The Lt. Governor (Administrator) of Mizoram is pleased to order creation of the following 3(three) new Agriculture Sub-Divisions under the Agriculture Department, Government of Mizoram.

HNAHTHIAL AGRIL. SUB-DIVISION

Headquarters - Hnahthial.

BOUNDARY DESCR: The jurisdiction of Hnahthial Agriculture Sub-Division will comprise a part of Lunglei District. The boundary of the Sub-Division on the south will follow the inter-District boundary of Lunglei and Chhimtuipui Districts inclusive of jurisdiction of Mualthuam. From this point i.e. at the confluence of River Mat and Koladyne River, the boundary of the Sub-Division will run to the north along the course of the Mat River right up to the district boundary line of Lunglei and Aizawl Districts inclusive of the village council jurisdiction of Rawpui village. On the north, the boundary will follow the inter-District boundary of Lunglei and Aizawl Districts and on the East, it will follow the International boundary of India and Burma.

TLABUNG AGRIL. SUB-DIVISION :

Headquarters - Tlabung.

BOUNDARY DESCRIPTION: The jurisdiction of the Sub-Division will cover the Western part of the Lunglei District. The boundary line of the Sub-Division on the south will follow the inter-District boundary of Lunglei and Chhimtuipui Districts inclusive of the village Council jurisdiction of Rualalung village. Thence, the boundary will run north-wards along the boundary of villages of Rualalung and Sailen and then follows the river course of Phairuang crossing Lunglei-Tlabung road at Phuaibuang Kai and thence runs north-wards along the River Phairuang upto the confluence point of River De and Kau. 3

From this confluence point the boundary goes along the River De upto the Changpui Ram and follows the village boundary between Changpui and Kawlhawk and thence meets the River Tut and thence the boundary runs northwards along the River Tut right upto the inter-Disirict boundary of Lunglei and Aizawl Districts and on the west along the international boundary of India and Bangladesh.

TUIPANG AGRIL. SUB-DIVISION

Headquarters - Tuipang

BOUNDARY DESCRIPTION : The jurisdiction of the Tuipang Agril. Sub-Division will comprise of the South-Eastern part of the Chhimtuipui district. On the South, the boundary of the Sub-Division will follow the international boundary of India and Burma running westwards right upto the Kolodyne River. From Kolodyne River it will run northwards along this river course right upto the confluence of Kawlchaw River and thence it will run East-wards following the village boundary of Maubawk and Theiva and bend northwards right upto the Tuitlawk River and from thence it will run east-wards between the boundary of Theiva and Thingsen right upto the boundary between Theiva and Chhuarlung and thence it runs south-wards along the village boundary of Chhuarlung and Theiva, Chhuarlung and Tuisi. And thence along the village boundary of Siata and Ainak and thence right upto the Kolodyne River and thence it runs southwards following the international boundary of India and Burma.
