NOTIFICATIONS

No. EXC 1/85/1, the 28th August. 1986. In exercise of the powers conferred by sub-section 2 of the Mizoram Excise Act, 1973, (Act No. 7 of 1974) the Lt. Governor (Administrator) of Mizoram is pleased to declare the following intoxicants as liquor:

- (1) All fermented liquors made from rice, millet or any other grain according to indigenous processes including Rakzu (distilled liquor), Tinzu, Zupui and Zufang, and
- (2) plain spirit, of a strength lower than forty degrees over proof, manufactured from rice or any other grain or material which is issued for consumption as potable alcoholic liquor and is not deemed to be foreign liquor, and
- (3) spirit, of a strength lower than forty degrees over proof, manufactured, with or without other material, from spirit other than spirit specified in item (2) above, which is issued for consumption as potable alcoholic liquor and is not deemed to be foreign liquor.

No. EXC 1/85/2, the 28th August, 1986. In exercise of the powers conferred by section 3 of the Mizoram Excise Act, 1973 (Act No. 7 of 1974) and in supercession of Notification No. EXC 33/74-79/24 Dated the 3rd January, 1985, the Lt. Governor (Administrator of Mizoram is pleased to declare the following intoxicants as foreign liquor :

- (1) Rum, whisky, brandy, gin, vodka, milk punch, liqueurs, cordials, bitters and wine or a mixture containing any of the liquors aforesaid,
- (2) spirit sophisticated or compounded so as to resemble in colour and flavour Rum, whisky, brandy, gin vodka, milk punch, liqueurs, cordials bitters or other similar potable alcoholic preparations.

- (3) Spirit including rectified spirit intended to be used for the manufacture of Rum, whisky, brandy, gin, vodka, milk punch, liqueurs, cordials, bitter or other similar portable alcoholic preparations. and
- (4) beer, ale, porter, stout, cider, perry and other similar potable fermented liquors :

Provided that the expression "Portable Foreign Liquor" shall not include, unless there is anything repugnant to the subject or in the context, the spirit including rectified spirit mentioned in item (3) as aforesaid.

No. EXC. 1/85/3, the 28th August, 1986. In exercise of the powers conferred by section 4 of the Mizoram Excise Act, 1973 (Act No. 7 of 1974), the Lt Governor (Administrator) of Mizoram is pleased to declare the limits of retail sale of intoxicants to an individual in a day as specified below throughout the whole of Mizoram, :-

Governor (Administrator) of Mizoram is pleased to prohibit possession and sale of any intoxicant by any person or class of persons in public places like Hotel, Restaurants, Bar and Club having no licence as per Rules 174, 175, 176 and 177 of the Mizoram Excise Rules, 1983 respectively, and also within the premises of church, school, theatre, public hall, playground and any other place of public resort,

No. EXC. 1/85/7 (A), the 28th August, 1986. In exercise of the powers conferred by section 45 of the Mizoram Excise Act, 1973 (Act No. 7 of 1974), the Lt. Governor (Administrator) of Mizoram is pleased to order that any member of Village Council and Administrative Officer within the Union Territory of Mizoram shall be bound to give immediate information to an Excise Officer, of any breach of any of the provisions of the aforesaid Act which have come to their notice and to aid any Excise Officer demanding his aid in the due discharge of his duties under the provisions of the Mizoram Act, 1973.

No. EXC. 1/85/5, the 28th August, 1986. In exercice of the powers conferred under sub-section (1) of section 17 of the Mizoram Excise Act, 1973 (Act No. 7 of 1974), the Lt.
