NOTIFICATION

No. A. 12018/31/80—APT (B), the 5th November, 1986. : In exercise of the powers conferred by the proviso to Article 309 of the constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated 21st January, 1972 and of all other powers enabling him in this behalf, the Administrator of Mizoram hereby makes the following rules further to amend the Mizoram Supply & Transport Deptt. (Supply Wing) (Group 'B' posts) Rectt. Rules, 1975 (issued under Notification No. STE. 17/80/275 dated 2.1.1980 published in official Gazette dated 20.3.1980) namely :—

1. Short title of : Commencement.

 These rules may be called the Mizoram Supply & Transport Deptt. (Supply Wing, Group 'B' posts) Rectt. First Amendment Rules, 1985.
(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Scheduled (now Annexure I) of the Mizoram Supply & Transport Deptt. (Supply Wing, Group 'B' posts) Rectt. Rules 1975 (hereinafter referred to as the said Rules) for the existing entries under Col. 1 in respect of the post of Asstt. Director of Supply, the following entries shall be substituted :--

"Assistant Director of Supply/District Civil Supply Officer"

3. In the schedule (now Annexure I)of the said Rules, for the existing entries under Col. 2 for the same post, the following entries shall be substituted :--

"3 (three) as may be sanctioned from time to time".

4. In the schedule (now Annexture I) of the said Rules, for existing proviso under Col. II for the same post, the following shall be substituted :--

"PROMOTION : From Superintendent of Supply with not less than 3 years regular service in the grade.

TRANSFER ON DEPUTATION : Officials from Central/State Govt./Union Territory Administration holding analogous posts.

"(Period of deputation including period of deputation in another excadre post held immediately preceeding this appointment in the same organisation/deptt. shall ordinarily not exceed 3 years).

4. In the scheduled (now Annexture I) of the said Rules, for the existing proviso under Col. 12 for the same post. Composition of the Selection Board shall be substituted :--
