In exercise of the powers conferred by the proviso to article 309 of the Constitution and all other powers enabling him in this behalf, the President hereby makes the following rules to amend the Mizoram Civil Service Rules, 1977, namely:—

- 1. (1) These rules may be called the Mizoram Civil Service (Amendment) Rules, 1987.
 - (2) They shall come into force with immediate effect.
- 2. In the Mizoram Civil Service Rules, 1977,-
 - (1) for sub-rule (2) of rule 4, the following shall be substituted, namely:-
 - " (2) The number of posts in the Selection Grade of the Service shall be 20 per cent of the authorised permanent strength of the Service";

- (11) for rule 6, the following shall be substituted, namely :-
- "6. Recruitment under sub rule (1) of the rule 5 shall be made on the recommendations of a Selection Board (hereinafter referred to as the Board) consisting of –

(i) an Officer in the Ministry of Home Affairs not below the rank of Additional Secretary to the Government of India (incharge of the Union Territories). Chairman

(ii) Joint Secretary (North East) in the Ministry of Home

Affairs Member.

(iii) Chief Secretary, Government of Mizoram - Member. "

(iii) for Schedule I, the following shall be substituted, namely:-
