# NOTIFICATION

No. A. 12018/12/82-APT (B) the 17th February, 1987. In exercise of the powers conferred by the proviso to Articles 309 of the Constitution read with the Govt. of India. Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st. January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the post of Archivist and Superintendent of archives under Education Department Govt. of Mizoram namely :--

- 1. Short title 1. These Rules may be called the Mizoram Education Department (Group 'B' Post Archives Unit) Recruitment Rules. 1936. and commencement
  - They shall come into force on the date of their publication in 2. the Official Gazette.
  - The Rules shall apply to the posts specified in Co<sup>1</sup>. 1 of the 2. Application : Annexure I hereto annexed.

shall be eligible for appointment to the said post.

Provided that the Administrator may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing so exempt, any person from the operation of this rules.

- Training and Every Govt, servant shall undergo such training or pass such 6 Departmental Examination as may be prescribed from time Departmental Examination: to time.
- Power to relax: Where the Administrator is of the opinion that it is necessary 7. or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
- Nothing in these rules shall effect reservation and other conother concescessions required to be provided for the scheduled castes, the sions : Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.
- All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the Saving: erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Noification No. 14/21/71-HMT (ii) dt. 21, 1. 1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
