## NOTIFICATION

S.O.- Whereas by its order date the 17th February, 1987, the Election Commission of India has directed that, pending the determination of the main dispute whether the Indian Congress (Socialist) has ceased to exist or not -

- (i) the group led by Shri Sarat Chandra Sinha be called and known as "Indian Congress (Socialist-Sarat Chandra Sinha)"; and
- (ii) the symbol "Charkha within a rectangle" be reserved for the said party;

Now, therefore, in pursuance of clause (a) of sub-paragraph (1) and sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission of India hereby makes the following amendment in its notification No. 56/84-I, dated the 13th November, 1984, published in the Gazette of India, Extraordinary Part II Section 3 (iii), dated the 16th November, 1984, and as amended from time to time namely -

In Table I appended to the said notification :-  
for the existing entry "4. Indian Congress (Socialist) ..... Charkha",  
the following entries shall be Substituted :-  
"4. Indian Congress (Socialist) ..... Charkha (Dispute pending before Commission)  
4.A. Indian Congress (Socialist-Sarat Chandra Sinha) ..... Charkha within a rectangle"

The above amendment shall be deemed to have taken effect from the 16th February, 1987.
