NOTIFICATION

S.O. - Whereas the Election Commission of India is satisfied that as a result of its poll performance at the General election of the Legislative Assembly held in February, 1987, in the State of Mizoram, the Mizo National Front is entitled for registration and recognition as a State Party in the State of Mizoram in terms of paragraph 3 and 6 of the Election Symbols (Reservation and Allotment) Order, 1968;

And whereas the Commission has decided to recognise the Mizo National Front as a State Party in the State of Mizoram and reserve the symbol "Tiger" for the said party in that State;

Now, therefore, in pursuance of clause (b) and (d) of sub-paragraph (1) and sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission hereby makes the following amendments in its notification No. 56/84-1, dated the 13th November, 1984, published in the Gazette of India, Extraordinary, Part II, Section 3 (iii) dated the 16th November, 1984, as amended from time to time, namely-

- (1) In Table 2 of the said notification, against the State of Mizoram, under columns 2 and 3 of the Table, FOR the entry "People's Conference Scales", the following entries shall be substituted :---
 - 1. "Mizo National Front......Tiger
 - 2. People's Conference..... Scales"

(2) In Table 4 of the said notification, against item No. 30 Mizoram mentioned in column 1 thereof the entry "17. Tiger" specified in column 2 thereof shall be deleted and the existing entry "18" shall be renur bered as "17".

The recognition granted to the above mentioned political party is subject to the following condition :--

- (i) The party shall communicate to the Commission without delay any change in its name and head office, Office bearers and their addresses and political principles, policies and objectives and any change and any other material matters;
- (ii) The party shall intimate the Commission immediately whenever any amendments are issued to party constitution along with the relevant documents like the notice for the meeting, minutes of the meeting where the amendments have been carried etc;
- (iii) The party shall maintain all the records like minutes books, accounts books, membership register, receipt books, etc. properly;
- (iv) The said records shall be open for inspection at anytime by the authorised representative (s) of the Commission; and
- (v) The recognition granted shall be reviewed by the Commission from time to time.
