NOTIFICATION

No. 100/MIZ—LA/1/87(1).— Whereas a vacancy has occurred in the Mizoram Legislative Assembly by reason of the resignation of the seat from 29—Sateek (ST) assembly constituency on 24th February, 1987, by Shri Laldenga, a member elected to that Assembly simultaneously from 29—Sateek (ST) and 34—Aizawi North-II (ST) assembly constituencies during the general election to the Mizoram Legislative Assembly held in February, 1987.
