NOTIFICATION

No. A. 12018/4/80 APT (B).: the 11th April 1987. In exercise of the powers conferred by the proviso to Articles 309 of the Constitution read with the Govt, of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Joint Director of Accounts & Treasuries/Budget Officer-cum-Deputy Secretary under Accounts & Treasuries Department, Govt. of Mizoram, namely:-

- 3. Numbers of posts classification and scale of pay
- Method of rectt. age limit and other qualification:

- 1. These Rules may be called the Mizoram Finance & Accounts Services (Group 'A' post) Recruitment Rules, 1987.
- 2. Application: 2. They shall come into force on the date of their publication in the official Gazette.

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 to the Annexure I aforesaid.

The age lim't qualifications and other matters relating to the said posts shall be as specified in columns 5 to 4 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt, of Mizoram from time to time.

Disqualification :

No person.

- a) Who has entered into or contracted a marriage with a person having a spouse living.
- b) Who having a spouse living has entered into or contracted marriage with any person.

shall be eligible for appointment to the said post.

Provided that the Administrator may of satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing exempt any person from the operation of this rules.

Training and Departmental Examination Every Govt. servant shall undergo such making or pass such Departmental Examination as may be prescribed from time to time.

Power to relax.

Where the Administrator is of the opinion that it is necessary or expendient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
