NOTIFICATION

No.A. 12018/34/80-APT (B) : the 1st May, 1987. In exercise of the powers conferred by the proviso to Article 309 read with Government of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21st January, 1972 and of all other powers enabling him in this behalf, the Governor of Mizoram hereby makes the following rules further to amend the Mizoram Education & Social Welfare Department (Group 'B' posts) Recruitment Rules, 1979 issued under Notification No. SWD.4/79/22 dt. 3rd March 1980, namely :-

1. (i) These Rules may be called the Mizoram Social Welfare Department (Group 'B' post) Recruitment (Second Amendment) Rules, 1987.
- (ii) They shall come into force on the date of publication in the Official Gazette .

2. In the Annexure I (formerly Schedule) under column 4 of the Mizoram Education & Social Welfare Department (Group 'B' post, viz. Child Development Project Officer) Recruitment Rules, 1979 (hereinafter referred to as the said Rules), for the existing pay scale, the following shall be substituted :-

“Rs. 650-30-740-35-810-EB-35-380-40-1000-EB-40-1200/- (pre-revised).

Rs. 2000-60-2300-EB-75-3200-100-3500/- (revised 1986).

3. In the Annexure I of the said Rules, for the existing provisions under column 7, the following shall be substituted :-

“Post Graduate Degree in Home Science or Social Work or Child Development or Nutrition. Female candidates should be given preference”

4. In the Annexure I of the said Rules, for the existing provisions under column 9, the following proviso shall be substituted :-

“Age - No.

Qualification - Promotees should possess atleast a Degree or Diploma or Certificate in Home Science or Social Work or Allied Social Science subject like Sociology, Economics and Anthropology.

5. In the Annexure of the said Rules, for the existing provisions under column 10, the following proviso shall be substituted :-

“ 75% by promotion failing which by Transfer on deputation ; 25% by direct recruitment. ”

6. In the Annexure I of the said Rules, for the existing provisions under column 11, the following proviso shall be substituted :-

“ Promotion : Supervisors of I.C.D.S. with 8 years regular service in the grade.”
(preferably Female Supervisors).

Transfer on deputation : Officers in the Central/State Govt./U.T. Administration

- i) holding analogous post ; or
- ii) with 5 years regular service in the grade of Rs. 550-900/-; or
- iii) with 8 years regular service in the grade of Rs. 425-800/-.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation department shall ordinarily not exceed 3 years).

In exercise of the powers conferred by the provision to article 309 of the Constitution read with Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21st January, 1972 and all other powers enabling him in this behalf the Governor of Mizoram hereby makes the following Rules further to amendment the Mizoram Cooperation Department (Group 'A'), Recruitment Rules, 1975, issued under Notification No. COOP.28/73/Pt. dt. 23rd August, 1979 namely :-

1. (1) This Rules may be called the Mizoram Cooperation Department. (Group 'A' Posts) Recruitment (First Amendment) Rules, 1987.

(2) They shall come into force on the date of publication in the official gazette.

2. In the schedule of the Mizoram Cooperation Department (Group 'A' Post) Recruitment Rules, 1975, under column - 11, for the post of Deputy Registrar of Co.op. Societies the existing provisions shall be substituted by the following :—

PROMOTION :— From Assistant Registrar of Cooperative Societies/Chief Audit Officer of Cooperative Societies having 5 years regular service in the Grade.

TRANSFER ON DEPUTATION :— Officers from Central or State Govt. or U.T. Administration holding analogous Posts. (Period of deputation including period of deputation in another ex-cadre posts held immediately preceding this appointment in the same or some other organisation/department shall ordinarily not exceed 3 years").
