In exercise of the powers conferred by the proviso to Articles 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of (1) Subject Matter specialist (2) Instructor (3) Soil Conservation Engineer/Junior project Officer (Engineer) (4) Section Officer-cum-silt Analysist (5) Horti cencus Officer (6) Assistant Project Officer (7) Sub-Divisional Agriculture Engineer under Agriculture Department namely :-

- 1. Short title and 1. These Rules may be called the Mizoram Agriculture Depart-Commencement: ment (Group 'B' posts) Recruitment Rules, 1987.
- 2. Application : 2. They shall come into force on the date of their publication in the Official Gazette.
- 3. Numbers of posts The number of the said posts, their classification and the classification and scale of pay attached thereto shall be as specified in scale of pay: Columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of recit., The age limit qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 14 of qualification : the said Annexure I.

Provided that the upper age limit prescribed for direct rect, may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time. - No person,
 - a) Who has entered into or contracted a marriage with a person having a spouse living.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing exempt any person from the operation of this rules.

Every Govt. servant shall undergo such training or pass such 6. Training and Departmental Departmental Examination as may be prescribed from time Examination: to time.

7. Power to relax: Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.

- 8. Reservation, other concessions :

Nothing in these rules shall effect reservation and other concessions required to be provided for the scheduled castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

9. Repeal and All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the Saving: erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21. 1. 1972 are hereby repealed.
