NOTIFICATION

No. A. 12018/45/30-API(B), the 11th August, 1987. In exercise of the powers conferred by the provise to articles 309 of the constitution and the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of HEALTH SUPERVISER and HEALTH WORKER in the Health & Family Welfare Department, Government of Mizoram, namely:—

- 1. Short title and: (1) These Rules may be called the Mizoram Health & Family Commencement Welfare Deptt. (Group 'C' posts) Recruitment Rules, 1987.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application: These Rules shall apply to the posts specified in column 1 of the Scheduled here to annexed.
- 3. Number of 3. The number of the said posts, their classification and the posts classification scales of pay attached thereto shall be as specified in and scale of pay: columns 2 to 4 to the Schedule aforesaid.
- 4. Method of rectt. 4. The age limit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 13 of qualification.:

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government of Mizoram from time to time,

5. Disqualification: No person.

a) Who has entered into or contracted a marriage with a person having a spouse living.

b) Who having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person and the other ground for doing exempt any person from the operation of this rules.

- 6. Training Every Govt. Servant shall undergo such training or pass such Deand Departmental Examination as may be prescribed from time to time. artmental Examination:
- 7. Power to relax: Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provision of these rules with respect to any class or category or persons.
- 8. Reservation and other concetion, other ssions required to be provided for the scheduled castes, to be proconcessions: vided for the Scheduled. Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.
- All Rules pertaining to these posts framed by the Governor of and Saving: Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21.1.1972 and Rectt. Rules for the post of Health Assistant (Re-designated as Health Worker) under Notification No. MFP. 174/73-75/21 dt. 3.4.1975. are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be made, done or taken under the corresponding provisions of these rules.

In exercise of the powers conferred by the proviso to Article 309 of the constitution, and the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of COMMUNITY HEALTH OFFICER under Health & Family Welfare Department, Government of Mizoram, namely:

- 1. Short title and Commencement:
- These tules may be called the Mizoram Health & F.W. Department (Group 'B' posts.) Recruitme t Rules, 1987.
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 2. Application:

These Rules shall apply to the posts specified in Column 1 of the Schedule hereto annexed

- 3. Numbers of posts 3. classification and scale of pay:
- The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Annexure i aforesaid.
- 4. Method of rectt, age limit and other qualification:
- 4. The age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 13 of the said schedule.

Provided that the upper age limit prescribed for direct rectt, may be relaxed in the case of candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. of Govt. of Mizoram from time to time.

Disqualifica- No person, tion:

- a) Who has entered into or contracted a marriage with a person having a spanse living,
 - b) Who having a spause living has entered into or contracted marriage with any person shall be eligible for appointment to the said post

Provided that the Governor may it satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for so doing, exempt any person from the operation of this rule.

Training and Departmental Examination:

Every Govt. servent shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Power to relax:

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram, Selection Board, relax any of the provisions of these rules with respect to any class or category or persons.

Reservation, other concessions:

Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt of Mizoram from time to time in this regard.

Repeal and Saving:

All Rules pertaining to these posts framed by the Governor of Assam or by the Govt of Assam and were in force in the erstwhile Mizo District, and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21. 1. 1972 are hereby repealed:-

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be made; done or taken under the corresponding provision of these rules.
