In exercise of the powers conferred by the proviso to Article 309 of the constitution, and the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Secretary, Zila Sainik Board/Zila Sainik Welfare Officer under Rajya Evam Zila Sainik Board, Mizoram, namely:

- 1. Short title and Commencement:
- 1. These rules may be called the Mizoram Rajya Evam Zila Sainik Board, (Group 'A' posts,) Recruitment Rules, 1987.
