NOTIFICATION

No. A. 12018/13/82-APT(B), the 10th September, 1987. In exercise of the powers conferred by the proviso to articles 309 the constitution of India, the Governor of Mizoram is pleased to make the following Rules, relating to the recruitment to the post of Deputy Superintendent of Police (Cipher) under Mizoram Police Radio Organisation, Government of Mizoram namely :-

- 1. Short title and : (1) These Rules may be called the Mizoram Police Radio Or-Commencement ganisation (Group 'B' posts) Recruitment Rules, 1987.
- 2. Application (2) They shall come into force on the date of their publication in the Official Gazette.

3. Numbers of (3) The number of the said posts, their classification and the posts classification scale of pay attached thereto shall be as specified in and scale of pay: columns 2 to 4 to the Annexure I aforesaid.

4. Method of rectt. (4) The age limit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 14 of qualification. : the said Annexure 1. Livia aterost visiting

> Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the scheduled castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

- 5. Disqualification :
- 5 No person.
- a) Who has entered into or contracted a marriage with a person having a spouse living

b) Who having a spouse living has entered into or contracted marriage with any person or shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing exempt any person from the operation of this rules.

- Training Every Govt. Servant shall undergo such training or pass such Departand Departmental Examination as may be prescribed from time to time.
 Examination:
- 7. Power to relax: Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
- 8. Reservation and other concessions: duled tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

All Rules pertaining to these posts framed by the Governor of and Saving: Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/ 21/71-HMT (ii) dt. 21.1.1972 are hereby repealed.

> Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
