ELECTION COMMISSION OF INDIA

Dated the 21st September 1987

NOTIFICATION

WHEREAS under the notification of the Election Commission of India, dated the 13th November, 1984, issued in pursuance of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, three parties, namely, (1) the Goa Congress, (2) the Maharashtra-wadi Gomantak and (3) Bhausaheb Bandodkar Gomantak who are notified as recognised State Parties in the then Union Territory of Goa, Daman and Diu.

AND WHEREAS, on the basis of the records available in its possession, the Election Commission of India is satisfied that the said Bhausaheb Bandodkar Gomantak Party has ceased to exist as a separate political Party as a consequence of its merger with the said Maharashtrawadi Gomantak Party.

AND WHEREAS under section 3 and 4 of the Goa, Daman and Diu Re-organisation Act, 1987, a new State, namely, the State of Goa comprising the territories in the Goa district of the said Union Territory and a new Union Territory namely, the Union Territory of Daman and Diu comprising the territories in the Daman and Diu districts of the said Union territory have been formed with effect on and from the 30th May, 1987.

AND WHEREAS the Election Commission of India has consulted the said Maharashtrawadi Gomantak Party and the said Goa Congress for the purpose of ascertaining as to whether they would be interested to be notified as recognised State Parties in both the new State of Goa as also the new Union territories of Daman and Diu.

Now, therefore, in pursuance of clauses (b) and (d) of sub-paragraph (1) and sub-paragraph (2) of paragraph 17 and paragraph 18 of the Election Symbols (Reservation and Allotment) Order, 1968, the Commission hereby makes the following further amendments in its notification No 56/84-I, dated the 13th November, 1984, published as O. N. 124 (E) in the Gazette of India, Extraordinary part II, Section 3 (iii) dated the 16th November, 1984 namely :-
