NOTIFICATION

No.A.12018/45/80-APT(B), the 5th October, 1987. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Receptionist and Multipurpose Rehabilitation Assistant in Health & Family Welfare Department, Government of Mizoram, namely:—

- 1. Short title and Commencement:
- 1. These rules may be called the Mizoram Health & Family Welfare Deptt. (Group C pests) Recruitment Rules, 1987.
- 2. Application:
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 3. Numbers of posts, classification and scale of pay:
- 3. The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Annexure I aforesaid.
- 4. Method of rectt., age limit and other qualification:
- 4. The age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt, may be relaxed in the case of candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Gevt, or Govt, of Mizoram from time to time.

- 5. Disqualification:
- 5. No person,
 - a) Who has entered into or contracted a marriage with a person having a spouse living.
 - Who having a spouse living has entered into or contracted marriage with any person or shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing, exempt any person from the operation of this rules.

6. Training and Departmental Examination:

Every Govt, servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time. Butter sel (Masters)

7. Power to relax: Where the Governor is of the opinion that it is necessary of expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
