In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Mizoram hereby makes the following rules further to amend the Mizoram Ministerial (Group 'C' posts) Recruiment Rules, 1980 issued under, Notification No. ABR. 66/80/6-11-dt. 10. 10. 1980 and the Mizoram Ministerial (Group 'C' post) Recruitment (First Amendment) Rules, 1981 issued under Notification No. ABR. 66/80/47 dt, 20. 11. 1981 namely :--

commencement.

1. Short title & : (1) These rules may be called the Mizoram Ministerial Service (Group 'C' post) Recruitment (Second Amendment) Rules, 1987.

> (2) They shall come into force on the date of their publication in the official Gazette.

2. In the schedule of the Mizoram Minisierial (Group 'C' posts) Recruitment Rules, 1980 and the Mizoram Ministerial (Group 'C' posts) Recruitment (First Amendment) Rules, 1981 (hereinafter referred to as the said rules) under column 10 for the existing provisions in respect of the post of Assistant and its equivalent posts, the following proviso shall be substituted :-

- "(1) 33_{3}^{10} by promotion on the basis of seniority-cum-fitness.
- (2) 33¹% by Limited Departmental Examination.
- (3) 33¹⁰/₂ by direct recruitment".

3. In the schedule to the said Rules, under column 12 for the post of Assistant, and its equivalent posts the existing proviso shall be constituted by the following:-

(1) Secretary, DP & AR or any officer as may be nominated by Chief Secretary-Chairman.
