Starting Point : Police lane-a Pu Rosanga (Vala) In bul kawra Lei dawh (Temporary bridge) chu teh tanna a ni.

Southern Point : He lei dawh atanga P.D.S.A. Ground lam panna kawng chu zawhin LDSA Ground sir thlang zelah a phei a. Pu Lalsanga In thlang kawrte (Dubhi lui hnar) chu a man phei a.

Eastern Side : He kawrte atang hian Hmar lamah ngil takin a phei a, UPC Biak in chhak lam zelah phei in Pu Lawmzuala In huamin kawrte Dry nullah a man phei a. Heta tang hian kawng chu zawh phei zelin Pu Tlangliana In huamin Thlanmual kawng tlang dung a man phei a. Thlanmual tlangdung kawng zawh thla zelin Thlanmual area tawp atanga Tuikhur kawng zawh zelin Pi Kapthangi In huamin Daithlang lui a man phei leh a.

Northern side : Daithlang lui hi zawh thla zelin kawngkan lui a zuk fin a. Tichuan Kawngkan lui zawhthla zelin Bawngveng leh Bazar veng inrina lui kawr Kawngkan lui a zuk finna thlengin.

Western side : He Kawngkan lui zu fintu kawrte hi zawh cho zelin a tira teh tanna Leihlawn (Temporary Bridge) bawr tha a han man leh ta a ni.
