#### NOTIFICATION

No. A. 12018/10/87-PAR(GS), the 17th March, 1988. In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following Rules, relating to the recruitment to the posts, of Joint Director, and Deputy Director Trade and Commerce Department, Government of Mizoram, namely:

- 1. Short title and (1) These Rules may be called the Mizoram, Trade & Comcommencement: merce Department (Group 'A' posts) Recruitment Rules 1987.
- 2. Application: (2) They shall come into force on the date of their publication in the Official Gazette.
- 3. Numbers of (3) The number of the said posts, their classification and the posts classification scale of pay attached thereto shall be as specified in and scale of pay: columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of rectt. (4) The age Bmit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 14 of qualifications: the said Annexure I.

Provided that the upper age limit prescribed for direct recit, may be relaxed in the case of candidates belonging to the scheduled castes, Scheduled Tribes and other special categories of pers ns in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

- a) who has entered into or contracted a marriage with person having a spouse living.
- b) who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing exempt any person from the operation of this rules.

7. Power to relax.

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category or persons.

8. Reservation, other consessions.

Nothing in these rules shall effect reservation and other concessions required to be provided for the scheduled castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Mizoram from time to time in this regard.
