(Act No. 4 of 1988).

A C T

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Mizoram for the services of the financial year 1988-89.

BE it enacted by the Legislative Assembly of Mizoram in the Thirty Ninth Year of the Republic of India as follows :

1. This Act may be called the Mizoram Appropriation (No. 2) Act, 1988. Short title.

2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sums of three hundred thirty two crores twenty seven lakhs and twenty six thousand rupees towards defraying the several charges which will come in course of payment during the financial year 1988-89 in respect of the services specified in column 2 of the Schedule. Issue of Rs 3,32,27,26,000.00 from and out of the Consolidated Fund of the State of Mizoram for the financial year 1987-88.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
