In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following Rules, relating to the recruitment to the post of Ferro-Printer under Local Administration Department (Town & Country Planning Wing) Govt. of Mizoram, namely :-

- 1. Short title and (1) These Rules may be called the Mizoram Local Adminiscommencement : tration, Town & Country Planning Deptt. (Group 'C' posts) Recruitment Rules, 1988.
 - Application : (2) They shall come into force on the date of their publication in the Official Gazette.
- 3. Number of (3) The number of the said posts, their classification and the posts/classification scale of pay attached thereto shall be as specified in and scale of pay;, columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of rectt. (4) The age limit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 14 of qualifications. : the said Annexure 1.

Provided that the upper age limit prescribed far direct rectt. may be relaxed in the case of candidates belonging to the scheduled castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Governn.cnt of Mizoram from time to time. Disqualification : 5. No person.

a) Who has entered into or contracted a marriage with a person having a spotse living.

b) Who, having a spouse living has entered into or contracted marriage with any person or shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person from the grounds for doing, exempt any person from the operation of these rules.

6. Training and Departmental Examination :

Every Govt. Servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

- 7. Power to relax : Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category of persons.
- Reservation, other concessions :
