NOTIFICATION

No. A. 12018/1/86-P&AR(C), the 7th March 1989. In exercise of the powers conferred by the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Administrative Officer under the Govt. of Mizoram, namely :--

- 1. Short title and commencement 1. These Rules may be called the Mizoram Administrative Officer (Group 'A' posts) Recruitment Rules, 1989.
- 2. Application 2. They shall come into force on the date of their publication in the official Gazette.
- 3. Numbers of posts 3. The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of rectt 4. The age limit qualifications and other matters relating age limit and other to the said posts shall be as specified in columns 5 qualifications . to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belong to the scheduled Castes, Scheduled Tribes and other special categories or persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time. 5.

- Disgualification 5. No person,
 - (a) Who has entered into or contracted a marriage with a person having a spause living.
 - Who having a spause living has entered into or b) contracted marriage with any person

shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the other party to the marriage and that there are other grounds for doing exempt any person from the operation of this rules.

Every Govt. servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Board, relax any of the provisions of these rules with respect to any class or category
