NOTIFICATION

No. A, 12018/45/80-APT(B), the 7th June, 1989. In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Rehabilitation Assistant under Health and Family Welfare Department, Government of Mizoram, namely.

- 1. Short title and commencement: 1. These Rules may be called the Mizoram Health & Family Welfare Department, (Group 'B' posts) Recruitment Rules, 1989.
- 2. Application: 2. They shall come into force on the date of their publication in the Official Gazette.


