Where 'MZ' stands for Mizoram, 01, 02, 03 represent code numbers for various Registering authorities and 0001 represents four digit number allocated to a vehicle. Where the four figures reaches 9999, the next series shall begin with alphabet 'A' followed by not more than four figures and thereafter with alphabet 'B' followed by not more than four figures and so on until all the alphabets, excluding 'I' and 'O' are exhausted.

This shall come into force with effect from the date of publication in the Mizoram Gazette.
