NOTIFICATION

NO.56/89-(1).-WHEREAS vide its order dated 27th October, 1989, the Election Commission of India has decided purely as an interim arrangement to recognise a group of 'Indian Congress (J)-Bhalla Group' led by Shri Balraj Trikha as a State Party in the State of Haryana pending determination of the main dispute in the party;

AND WHEREAS the said party will be known as 'Indian Congress (J)-Trikha Group' and the Symbol "Swastik within a circle" has been reserved for the said party in the State of Haryana;

AND WHEREAS on an application under Paragraph 10 of the Election Symbols (Resevation and Allotment) order, 1968, made by 'Indian Congress (J) Bhalla Group', a recognised State Party in the State of Haryana with the Symbol 'Scales within a rectangle' reserved for it in the said State, for the allotment of said symbol to its candidates in all other States and Union Territories. Commission has decided to grant concession under para 10 to the said party in respect of all States/Union Territories except the State of Punjab and Union Territory of Pondicherry and has also decided to delete the free symbol 'Scales' from the list of free symbols in the States and Union Territories concerned and to include the symbol 'Scales within a rectangle' as a free symbol in respect of all the States and Union Territories except the State of Punjab and Union Territory of Pondicherry;

NOW THEREFORE, in exercise of the powers conferred by Section 29A of the Representation of People Act, 1951 read with Article 324 of the Constitution of India, Rules 5 and 10 of the conduct of Elections Rules, 1961 and clauses (b)

and (d) of sub-paragraph (1) and (2) of Paragraph 17 of the said symbols Order and all other powers enabling the Commission in this behalf. Election Commission of India hereby makes the following amendments on its notification No. 56/89, dated 23rd October, 1989 published in the Gazette of India Extraordinary, Part II, Section 3 (iii) namely—

(I) In Table II, against the State of Haryana, under column 2 and 3 the entry "1B Indian Congress (J)- Trikha Group...Swastik within a circle" **"SHALL BE INSERTED ;**

(II) IN Table IV—
