NOTIFICATION

No. A.12018/1/89-P&AR(GSW), the 6th. November, 1989. In exercise of the powers conferred by the provise to Article 309 of the Constitution of India, the Governor of Mizo, am is pleased to make the following rules relating to the recruitment to the post of Group 'A', 'B', 'C' & 'D' Post in the Ministers Secretariat, Govt. of Mizoram, namely:-

- 1. Short tide 1. These Rules may be called the Mizoram Minsters' Secretariat and commencement : 1989. (C'&'D' posts) Recruitment Rules, 1989.
- 2. Application: 2. They shall come into force from the date of their publication in the official Gazette.
- 3. Numbers of 3. The posts, classification and constant of pay:
- 3. The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of 4. The age limit, qualifications and other matters relating to rectt., age limit and other qualifications and other qualifications in columns 5 to 14 of the said Annexure—I.
 Provided that the upper age limit prescribed for direct for direct to the said annexure.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belong to the Scheduled castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time, 5. Disgualification : 5. No person,

> a) Who has entered into or contracted a marriage with a person having a spause living.

b) Who having a spause living has entered into or contracted marriage with any person shall be eligible for appointment to the said post. Provided that the Govermay if satisfied that such marriage is permissible nor under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so exempt any person from the operation of this rules.

- 6. Training and 6. Every Govt. servant shall undergo such training or pass such Departmental Examination as may be prescribed from Departmental Examination : time to time.
- Power to Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons 7 relax : to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons
- 8. Reservation, Nothing in these rules shall effect reservation and other other concessions : concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Mizorain from time to time in this regards.
- 9. Repeal & All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force Saving : in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21. 1. 1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be decmed 10 have been made, done or taken under the corresponding provisions of these rules.
