## NOTIFICATION

No. A. 11011/1/MCS (G), the 23rd January, 1990. In exercise of the powers conferred under the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following regulations relating to the Departmental Examination of the Mizoram Civil Service.

In pursuance of Rule 19 of Mizoram Civil Service Rules 1988 read with Rule 10 of the said Rules, 1988, the Governor of Mizoram is pleased to make the following regulations namely :—

1. Short Title — These regulations may be called the Mizoram Civil Service (Departmental Examination) Regulations 1990.
2. Definitions — (1) In these regulations, unless the content otherwise requires:—
  - (a) 'Commission' means Mizoram Public Service Commission;
  - (b) 'Chairman' means the Chairman of the Mizoram Public Service Commission;
  - (c) 'Government' means Government of Mizoram.

(2) All other words and expression used in these regulations and not defined shall have the meanings respectively assigned to them in the MCS Rules, 1988 as amended from time to time.

3. Departmental Examination — (1) Every probationer who is in Junior Grade of MCS shall, during the period of probation, or as may be prescribed by the Commission/Government, appear at a Departmental Examination and shall be required to pass the minimum standard prescribed at such Examination before they are considered for promotion to the next higher grade.

(2) M.C.S. Officers who are already in Senior Grade and Junior Administrative Grade shall also appear at Departmental Examination and pass such examination if they have not already passed any departmental examination in the past under the Government of Assam or Government of India, before they are considered for Promotion to the next higher grade.

(3) The Examination shall be conducted by the Commission/Government in the manner laid down in these regulations.

(4) The exact dates on which the examination shall be held shall be fixed by the Commission/Government.

4. Syllabus for Departmental Examination—The Examination shall be two parts as mentioned below :—

(a) PART I—WRITTEN EXAMINATION

The subjects for the examination and the maximum marks allotted to each of the subjects shall be as follows :—

Subject	Maximum
(1) General Financial Rules including Delegation of Financial Power Rules 1978, Central Treasury Rules etc.	300 marks
(2) C.C.S. Pension Rules 1972	100 marks
(3) F.R. & S.R.	100 marks
(4) C.C.S. (C.C.A.) Rules 1965	100 marks
(5) C.C.S. (Conduct) Rules 1964	100 marks
(6) All local acts, rules, regulations etc. applicable in Mizoram (such as Land Revenue Regulations, Administration of Justice Rules, all Rules and Regulations framed by the then District Councils, etc).	200 marks
(7) Central Secretariat Manual of Office Procedure.	100 marks
(8) General Law Papers covering Criminal Procedure Code, Civil Procedure Code, Evidence Act and Constitution of India relating to Service Provisions.	200 marks
(9) Mizo Language of Middle School Standard.	100 marks

(b) PART II - QUALIFYING TEST

Qualifying Test shall be held in the following subjects, namely :-

English - The Test will comprise translation, free composition, conversation and dictation. The knowledge of grammar will be tested by composition, conversation and by passages for comments.

5. Minimum Marks - Candidates shall be required to obtain such minimum number of marks in each subject at the written examination under clause (a) of regulation 4, and to pass the qualifying tests under clause (b) of the said regulation by such standards as may be determined by the Commission/ Government.

6. Notwithstanding anything contained in the foregoing provisions the Governor of Mizoram on the advise of the Commission/Government may exempt by general or special order any officer governed by the M.C.S. Rules, 1988 as amended from time to time from the requirement of passing the departmental examination in the interest of the Public service if in the opinion of the Governor such insistence on passing of the said examination will impose undue hardship and disadvantage to such officer.
