NOTIFICATION

No.A.11011/1/MCS(G), the 23rd January, 1990. In exercise of the powers conferred under the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules to amend the Mizoram Civil Service Rules, 1988 read with the Mizoram Civil Service (Amendment) Rules, 1988 as notified vide Government of Mizoram, Department of Personnel and Administrative Reforms No.11011/1/MCS(G) dt.15.7.1988 and even number dt.19.12.1988 in the Mizoram Gazette:—

Short title and Commencement:

- (1) These rules may be called the Mizoram Civil Service (Amendment) Rules, 1990
- (2) They shall come into force on the date of their publication in the official Gazette.

General Amendment:

- (1) In sub-rule (ii) of Rule 5 of the amended Rules, the figure 5% shall be substituted by the figure 8%.
- (2) Deletion of Rule 9:
 Rule 9 in the Amended Rules shall stand deleted.
- (3) Substitution of Schedule I (a)
 Schedule: I (a) (Authorised Permanent strength of the Mizoram Civil Service)
 in the amended Rules shall be substituted by Schedule I namely:
