NOTIFICATION

No. A. 12018/9/80-APT(B), the 25th January, 1990. In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts (s) of - Additional Superintendent of Police (Ministerial), Uniformed Cadre in Mizoram Police Department namely

- 1. Short title and (i) These Rules may be called the Mizoram Police (Ministecommencement: rial) Service (Group'A') Recruitment Rules, 1990.
- 2. Application: ii) They shall come into force from the date of their publication in the Official Gazette.
- 3. Number of posts classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 to the Annexure I aforesaid.
 - Method of rectt. The age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct recit, may be relaxed in the case of candidates belonging to the Scheduled castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Governmen of Mizoram from time to time.

Disqualification:

No person,

a) Who has entered into or claim the promitiage with a person having a spause living

b) Who, having a spause living has entered into or contracted marriage with any nor a shall be eligible for appointment to the said post.

Provided that the Governor may, it satisfied that such marriage is permissible under the resonal as applicable to such person and the other marriage and that there are other grounds in the doing, any person from the operation of this rules.

Training and 6. Departmental Examination:

Every Govt, servant shall undergo with training or pass such Departmental Examination as the late pre-cribed from time to time.

6(A) Notwitstanding anything contained these Rules, the Governor of Mizoram, in public is trest, have the right and power to transfer any Officer or Official, recruited in accordance with these Rules to ac post/posts/service specified in Schedule/Annexure to tiese rules to any other post or position which is equivalent in rank or grade.
