NOTIFICATION

No. A. 12018/90/80-APT(B), the 8th March, 1990. In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts (s) of - Dy. Director (Nursing), Matron/Asstt. Director (N)/Nursing Officer (Principal)/Principal Tutor under Health & Family Welfare Department, Govt. of Mizoram, namely:

- 1. Short title and (i) These Rules may be called the Mizoram Health & Family commencement: Welfare Deptt. (Group 'A' Posts) Recruitment Rules, 1990.
- 2. Application: (ii) They shall come into force from the date of their publication in the Official Gazette.
- Number of The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 to the Annexure I aforesaid.
- Method of rectt. The age limit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time totime.

Disqualification:

No person,

- a) Who has entered into or contracted a marriage with a person having a spause living;
- b) Who having a spause living has entered into or contracted marriage with any person shall be eligible for appointment to the said post, or

Provided that the Governor may if satisfied that such marriageis permissible under the personal law applicable to the marriage to such person and the other party and that there are other grounds for so doing any person from the operation of this rules.

Training and 6. Departmental

training or pass Every Govt. servant shall undergo such such Departmental Examination as may be prescribed from time to time.

6(A) Notwitstanding anything contained in these Rules, the Governor of Mizoram, in public interest, have the right and power to transfer any Officer or Official, recruited in accordance with these Rules to the post/posts/service specified in Schedule/Annexure to these rules to any other post of position which is equivalent in rank or grade. Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Fromotion Committee through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect reservation and other other concessions: concessions required to be provided for the Scheduled Castes, persons the Scheduled Tribes and other categories of accordance with the orders issued by the Central Govt. Govt. of Mizoram from time to time in this regards.

> All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21, 1, 1972 and No.MFP. 174/73-75/21 dt.3.4.75 are hereby repealed in respect of Matron.

> Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed have been made, done or taken under the corresponding provisions of these rules.
