## NOTIFICATION

No. A. 12018/8/87-PAR (GS), the 20th March, 1990. In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of - Station Superintendent (MST)/Transport Officer under Transport Department, Government of Mizoram namely:

- 1. Short (itle and commencement:
- (i) These Fules may be called the Mizoram Transport Department (Group 'B' post) Recruitment Rules, 1989.
- (ii) They shall come into force from the date of their publication in the official Gazette.
- 2. Application:

The rules shall apply to the post(s) specified in col. 1 of the Annexure-1 hereto annexed.

- 3. Numbers of posts classification and scale of pay:
- The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 to the Annexure I aforesaid.
- 4. Method of rectt, age limit and other qualifications:

The age limit qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time

5. Disqualification:

No person,

a) who has entered imp or o tracted a marriage with a person having a cruse living;

or

b) who, having a spouse fixing has entered into or contracted marriage with any person shall be eligible for appoint ant to the said post.
