AN ACT

THE MIZORAM APPROPRIATION (NO. 2) ACT, 1990.

AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of mizoram for the service of the financial Year 1990—91.

BE it enacted by the Legislative Assembly of Mizoram in the Forty First Year of Republic of India as follows:

Short title

- 1. This Act may be called the Mizoram Appropriation (No. 2) Act, 1990.
- Issue of Rs. 4,03,37,16, 000,00 from and out of the Consolidated Fund of the State of Mizoram for the financial year 1990—91.
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate to the sum of four hundred and three crores thirty seven lakhs, sixteen thousands towards defraying the several charges which will come in course of payment during the financial year 1990-91 in respect of the services specified in Column 2 of the Schedule.

Appropriation 3 The sums authorised to be paid and applied from and out of the Consolidated Fund of the State Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
