No. LJD. 10/90/5, the 28th March, 1990. The following Act of the Mizora m Legislative Assembly, which received the assent of the Governor is hereby published for general information.

> The Mizoram Act No. 1 of 1990 The Mizoram Appropriation (No. 1) Act, 1990

(Received the assent of the Governor of Mizoram on the 27th March, 1990).

## AN

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Mizoram for the services of the financial Year 1989—90.

BE it enacted by the Legislative Assembly of Mizoram in the Forty-First Year of the Republic of India as follows:

1. This Act may be called the Mizoram Appropriation (No. 1) Short title. Act, 1990.

Issue of Rs. 79,36,08,000. 00 from and out of the Consolidated Fund of the State of Mizoram for the financial year 1988—90.

2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sums of seventy nine crores thirty six lakhs and eight thousand towards defraying the several charges which will come in course of payment during the financial year 1989-90 in respect of the services specified in column 2 of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
