## NOTIFICATION

No.A.12018/21/80-APT(B), the 3rd April 1990. In exercise of the powers confered by the proviso to Article 309 of the Constitution of India, the Governor of Mizorani is pleased to make the following rules relating to the recruitment to the post (s) of Senior Laboratory Technician.

1. Short title and (i) These rules may be called, the Mizoram, Health \& FamiCommencement ly Welfare Department (Group ' $B$ ') Recruitment Rules 1990.
(ii) They shall come into force from the date of their publication in the Official Gazette.
2. Application. The rules shall apply to the post (s) specified in Col. 1 of the Annexure-I hereto annexed.
3. Numbers of posts The number of the said posts, their classification and the classification and scale of pay scale of pay attached there to shall be as specified in Columns 2 to 4 to the Annexure-I aforesaid.
4. Method of rectt. The age limit qualifications and other matters relating to age limit and other the said post shall be as specified in columns 5 to 14 of qualification. the Said Annexure-I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belong to the Scheduled Castes Scheduled Tribes and other special categories or persons in accordance with the orders issued by the Central Govt. of Mizoram from time to time.
5. Disqualification.

6, Training and Departmental Examination
7. Power to relax.
8. Reservation other consessions.
9. Repeal \& Saving.

No person,
a) who has entered into or contracted a marriage with a person having a spouse living.
b) who having a spouse living has entered into or contracted marriage with any person
shall be eligible for appointment to the said post.
Provided that the Governor may if satisfied that such marriage is permissibie under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing exempt any person from the operation of this rules.
Every Govt. servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
6. (A). Notwithstanding anything contrained in these Rules, the Governor of Mizoram in public interest, have the right and power to transfer any officer or official, recruited in accordance with these Rules to the post/posts! service specificd in Schedule/Annexure to these rules to any other post of position which is equivalent in rank or grade.
Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Mizoram Selection Committee/Departmental Promotion Committee through the Department of Personnel \& Administrative Reform, relax any of the provisions of these rules with respect to any class or category or persons.
Nothing in these rules shall effect reservation and other conoessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Mizoram from time to time in this regards.
All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21.1. 1972 are hereby repealed.

Provided that any ordor made or anything done or any aotion taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
