#### NOTIFICATION

No. A. 12018/3/87-PAR(GS), the 14th September, 1990. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post (s) of Yoga Instructor, Organiser/District Organiser (Scouts), Organiser/District Organiser (Guides), Asst. Organiser(Scout/Guides), Coach Grade III, Physical Education Teacher (under Graduate), Asst. Organiser (Adventure), under Sports & Youth Services Department, Government of Mizoram.

- 1. Short title and (i) These Rules may be called the Mizoram Sports & Youth commencement: Services Department (Group 'B' & 'C' posts) Recruitment Rules, 1990.
  - (ii) They shall come into force from the date of their publication in the Official Gazette.
- 2. Application:

The rules shall apply to the post(s) specified in col. 1 of the Annexure—I hereto annexed.

3. Number of posts, classification and scale of pay:

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 to the Annexure I aforesaid.

4. Method of rectt.
age limit and other
qualification:

The age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Annexure I.

Provided that the upper age limit prescribed for direct rectt, may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government of Government of Mizoram from time to time.

Disqualification.

No person,

- a) Who has entered into or contracted marriage with a person having a shouse living.
- b) Who, having a sponse living has entered into or contracted marriage with any person shall be leligible for appointment to the said post.

Provided that the Governor may, it satisfied that such marriage is permissible under the personal law applicable to such person and the other party of the marriage and that there are other grounds for the second some exempt any person from the operation of this cales.

5. Training and Departmental Examination.

Every Govt, servant shall undergo such leaining or pass such Departmental Examination as may be prescribed from time to time.

6(A) Not withstanding anything contained a case Rules, the Governor of Mizoram, in public interest have the right and power to transfer any Officer or Dacial, recruited in accordance with these Rules to the cost/posts/service specified in Schedule/Annexure to their rules to any other post or position which is equivalent to rank or grade.

Where the Governor is of the opinion is it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing in consultation on the Selection Committee/Departmental Promotion Consultation for the Selection Committee/Departmental Promotion Consultation Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Control Govt. or Mizoram from time to time in this regards.

All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Winistry of Home Affairs Notification No. 14/21/71-HMT (ii) ented 21. 1. 1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
