#### THE LUSHAI HILLS DISTRICT (VILLAGE COUNCILS) (SECOND AMENDMENT) ORDINANCE, 1990

No. 4 of 1990.

Promulgated by the Governor on the Forty-First Year of the Republic of India.

#### An Ordinance

Further to amend the Lushai Hills District (Village Councils) (Amendment) Ordinance, 1990.

Whereas Assembly is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

Now, therefore, in exercise of the powers conferred on him by clause (1) of Article 213 of the Constitution of India, the Governor of Mizoram is pleased to promulgate the following Ordinance, namely :--
